Talenta Academy's Conditions of Registration, Withdrawal, Payment, and Refund Policy

1. Fees must be paid in full prior to the first class by cash or cheque. Failure to pay, may result in late payment charges of 4% added to your monthly balance at the end of each month. School has the right to remove students from any class for non-payment.

2. Registrant may require to present evidence of admission requirements.

3. Student must have completed the prerequisites courses perior to starting the courses.

Failure to submit the prerequisite may result in receiving No credit, or refund.

4. The school reserves the right to cancel any courses/classes before starting.

 Registration may not be valid until we receive your documents for your prerequisite(s), Canadian Citizenship Proof, Health Card, the registration fee, and student code of conduct
 If proper documents or payment is not received on time, the student will be dropped out

without further notice to accomadate the seat for another student.

5. All overdue account balances are charged at 4% per month cumulative.
